June 6th Farm Dog Geese am and Farm Dog Cattle pm

Geese will include 5 Africans and 5 Buffs in each run. Maximum of **12** runs. **\$50.00** per run

Cattle will include 6 head of beef breeds in each run. Maximum of **12** runs. **\$60.00** per run

June 7th Farm Dog Sheep am and Farm Dog Mixed pm

Sheep --Dorpers, Goats-- young Boers.

Sheep runs will include 10 head: (5 ewes, 5 collared lambs). Maximum **16** runs

Mixed will include 5 head beef breed cattle, 5 Dorper sheep and 5 Boer goats. Mixed maximum of **12** runs. **\$60.00** per run. All cattle will be set by riders on horseback. Sheep, geese and Goats will be set by dog and handler. All stock will be held until competing dog is sent.

If entering all 4 Farm Dog classes the entry fee will be **\$200.00** for the 4 classes.

A Special Prize of \$150 dollars will be awarded to the dog scoring the highest total score in the four farm dog classes. A Silver Buckle will also be awarded to the winner. Must compete in all 4 classes to be eligible for money and buckle.

Ribbons—1st—4th for all classes. Special Award to highest scoring dog in Geese; Cattle; Sheep and Mixed.

Pre entries Entries open **May 6th** and close **May 31st**. Day of entries accepted if there are openings with and additional fee of 10.00 per entry. Handlers meeting at 7:30 AM. Run order will be drawn prior to trial. Post entries will run last. Advanced will run first with Open to follow. Refund with vet cert. only. Substitutions allowed.

Directions: From I-5 southbound, Exit at 2nd Central Point Exit and follow directions to highway62/ Crater Lake Hwy. At Eagle Point turn right onto Royal (at Info Center.) Follow Royal Ave. thru Eagle Point. Royal Ave becomes Brownsborough Hwy. Stay on this road until you are out of Eagle Point and come to a Y. At the Y take the left fork which is Brophy Rd. Follow Brophy Rd to the second Y. Take the right fork which is Worthington Rd. This road goes down a steep gully and up. We are at the top of the gully on the right. Overnight parking permitted (no hookups).
