5 head of beef breed cattle	9 runs
<b>Oct 3, 2024 PM Mixed Farm Dog: Divisions; Open and Advanced</b>	
5 head beef cattle, 5 Dorper sheep, 5 young Boer goats	12 runs
<b>4<sup>TH</sup> Farm dog class run on</b>	
<b>Oct 4, 2024 AM Farm Dog Sheep Divisions: Open and Advanced</b>	16 runs

*Sheep, goats and geese will be set by dog and handler. Cattle for mixed and cattle will be set by people on horseback.*

**Competition** If a tie results the tie will be broken by time If still tied, Gather points will be used. Bitches in heat will run in order.

**Entry fees** Sheep, Mixed, Cattle \$60. Per run Geese Class \$50.00 per run (If entering all 4 classes with one dog entry fee will be \$200.00)

**Pre entries** Open Sept 3rd and close Sept 28, 2024. Day of entries accepted if there are openings for \$10 extra per entry. Handlers meeting at 7:30 AM. Run order will be drawn prior to trial. Advanced will run first with Open to follow. Refund with vet cert. only. Substitutions allowed.

**Awards:** Ribbons First thru Fourth. Prize for 1<sup>st</sup> places. Plaques for Highest Scoring dog in each trial

**Directions:** From I-5 southbound, Exit at 2<sup>nd</sup> Central Point Exit and follow directions to highway62/ Crater Lake Hwy. At Eagle Point turn right onto Royal (at Info Center.) Follow Royal Ave. thru Eagle Point. Royal Ave becomes Brownsborough Hwy. Stay on this road until you are out of Eagle Point and come to a Y. At the Y take the left fork which is Brophy Rd. Follow Brophy Rd to the second Y. Take the right fork which is Worthington Rd. This road goes down a steep gully and up. We are at the top of the gully on the right. Overnight parking permitted (no hookups).
